NOTE: A \$25 deposit will be required with all use of camp reservations for units and non-Council groups. A refund will be issued upon approved checkout with Ranger/Camp Master. Parking is permitted in designated areas only. There will be no charges for council or district events using meeting facilities. Fees always apply for individuals using bunk and dorm rooms. Camp properties are closed for legal holidays, when the Scout Center is closed (see council calendar). Camp is closed from June 1 through August 31st due to summer camp. Staff cabins are heated with access to heated central shower/toilet facility. Adult cabins are heated and include private bath. Mountain Man Village and Miner's Camp are tent sites, with tents provided to sleep 72. Non-Scout groups must include a **Hold-Harmless Agreement** with Application for Use of Camp Property.

- Fees above are daily/overnight.
- Unheated shower houses are open as weather permits, normally April 15th - October 15th. Cub World staff shower is available year-round.
- An application for Use of Camp Property must be filed with the Council Office no later than 72 hours prior to your arrival.
- If you need to cancel the **day of your outing**, please call the camp phone **513-831-8311** and advise Rangers you will not be using the facility.
- Arrival and departure for week-end camping: Check in: 5:00 - 9 p.m. Friday. Check out: No later than 3:00 p.m. Sunday.
- Campfires may be built in fire rings only. You are encouraged to bring you own firewood.
- Tiger Cubs are not permitted to camp overnight. Cub Scouts and Webelos must camp with parent/adult partner in 1:1 ratio.
- Two registered adult leaders are required. Coed overnight activities require male and female adult leaders.

I have read the **Camp Use Guidelines** and will ensure that all persons represented by this application comply with the rules of Camp use. I have enclosed a \$25 deposit with this application that will be refunded in cash provided our checkout meets approval of the Ranger on duty. I understand that all other fees due will be paid in full over and above the enclosed deposit, upon arrival at camp. If I fail to keep this reservation and do not notify the camp Ranger prior to our scheduled arrival time, I understand the \$25 deposit will be forfeited.
